#### MEDI CI NES PRI CI NG & REI MBURSEMENT WORKSHOP 2012

MAPS participated in this Workshop, which was held on 18-19 October at the Holiday Villa Subang.

Back to back to the DUNAS workshop, the Pharmaceutical Services Division, in collaboration with the WHO, organized the MEDICINES PRICING & REIMBURSEMENT WORKSHOP 2012.

Various interest groups were invited to participate.

The Objectives were:

- 1. To propose a sustainable price setting methodology which is implementable for Malaysia
- 2. To suggest a suitable mechanism for implementation of proposed price setting methodology
- 3. To recommend medicine price reimbursement which may be appropriate for Malaysia

To assist in the workshop were 2 WHO representatives viz: Dr Graham Harrison from the WHO Representative office and Emeritus Professor Lloyd Sansom, another consultant from WHO and who is attached to the University of South Australia.

The PSD will have further deliberations in order to take this Workshop proposals to the next level.

#### MALAYSI AN NATI ONAL MEDI CI NES POLI CY (DUNAS)

MAPS participated in this Workshop, which was held on 15-17 October 2012 at the Holiday Villa Subang.

The Malaysian National Medicines Policy, or Dasar Ubat Nasional (DUNAS)' objective is to promote equitable access to, rational use of quality, safe, effective and affordable essential drugs to improve the health outcomes of the people.

The existing DUNAS was from 2006 till 2012 and the Pharmaceutical Services Division (PSD) has been given the task to conduct a Full Term Review to set the policies for the ensuing 5 years. To do so, input and consensus from all stakeholders towards the suggestions of the components, and new strategies were sought at a Workshop held from 15-17 October in Holiday Villa Subang.

To assist in this Review, a WHO consultant, Emeritus Professor Lloyd Sansom had been invited. In addition, the local stakeholders consisting of MAPS, MOPI, PhAMA, MMA, CAP, MITI, PEMANDU, Ministry of Defense, Ministry of Higher Education, Insurance Agencies, APHM, MPS, MyCC, CRCMIDA were also invited to present their respective views.

The workshop went through the earlier 2006-2012 report and made further recommendations. The components were :

- 1. Quality, Safety and Efficacy of Drugs
- 2. Drug Accessibility
- 3. Quality Use of Medicines
- 4. Human Resources Development, Research & Development, Technical Co-operation

#### Second Extraordinary General Meeting

Some resolutions in the previous general meetings were approved and some others were not acceptable to the Registrar of Societies (ROS). A second EGM was called on the 24th October to further amend the resolutions in order to gain the ROS approval.

The meeting, held at the MAPS secretariat, was called to order upon reaching the quorum. Some clarifications were made, and the resolutions were finally approved by the general meeting.
